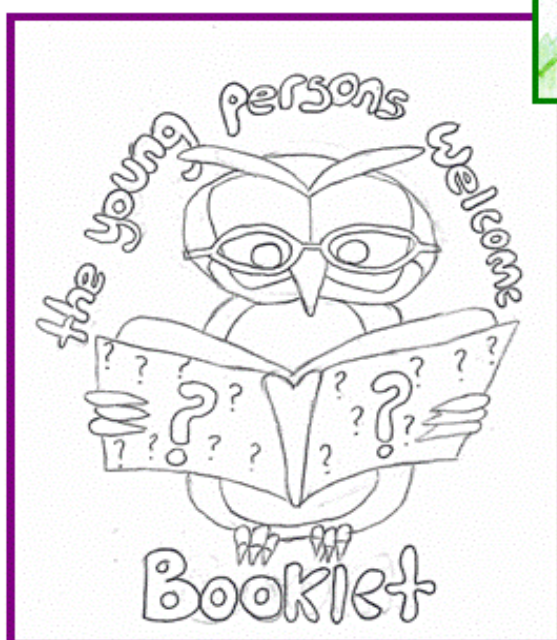

Who we are



We are Priory Fostering Services.

We provide foster placements for young people aged between 0 and 18.

We will work hard to make sure you are healthy and safe.

We will also help you to enjoy and achieve things in your life.

We will help you to be a good member of your community and have enough money to spend or save as you wish.

What you should expect of us

Our Foster Carers will treat you in the same way as a member of their family.



They will:

- respect your privacy and you will have your own room.
- listen to what you have to say.
- help and support any contact with your family.
- help you go to school and with your homework. If you cannot go to school we will teach you somewhere else.
- help you to be healthy and to stay healthy by making sure you have a doctor, dentist and optician.
- encourage you in the things you are good at.
- treat you as an individual and speak up on your behalf.
- help you to get ready to move into adult life.
- help you keep safe photographs and favourite possessions and a record of the time you spend with your foster family.
- help you make a complaint if you are not happy with the service given to you.



What we will expect of you

- To treat our home and family members with care and respect
- To work with us to create a happy home where all members feel cared for and valued
- To be open and honest with us and to value our property and possessions
- To let us know where you are and who you are spending time with outside of the home
- To spend your pocket money wisely and not to take drugs
- To use the internet and social media wisely
- To help with the housework, shopping and cooking
- To treat all family members kindly and not to bully anyone because of the way they live or the way they think about things

- To be given good information and advice
- To have a say
- To complain or speak to someone if you are not happy

Be listened to


All of these people and organisations will listen to you and help you. They are there to make sure that rights are 4 you.
