## **ACTION TO TAKE IF AN ALLEGATION OF ABUSE IS MADE TO YOU:**

You should ensure the immediate safety of all individuals.

You should notify:

You should complete an electronic Incident Report (Electronic Reporting System)

Staff are advised to raise any immediate concerns verbally and follow the advice given, all concerns raised should be inputted onto the MIS system

You should follow the Procedures for referral that have been agreed with the Local Safeguarding Adults Team which can be found here: **safeguarding-adult-concern-form-guidance-note.doc (Live.com)**
